This is with reference to school application on the subject cited above. I am directed to convey approval of the Board for Fresh affiliation upto Senior Secondary level Switch over from other Boards (only schools who are al as per details given below :

Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school from class I to XII shall be restricted to 14 out of which the school can run not more than 02 sections in secondary classes i.e. 01 in class IX and 01 in class X and not more than 04 sections in senior secondary classes i.e. 02 in class XI and 02 in class XII, subject to the condition that the school shall not run more than 1/4 and 1/3 of the total sections running in the school at any point in time at the secondary level and senior secondary level, respectively. The optimum number of the students shall be restricted to 40 for a classrooms size of 500 sq ft and above. Further, increase of sections shall be subject to specific approval of the Board based on the request of the school as per affiliation bye law and availability of land and class rooms of greater than 500 sq ft dimension.
2	Separate reading for staff not seen in the Library, the school is required to create the separate reading area for the staff in the Library as per Sop's of the Board and submit the compliance through videography within 3 months on SARAS portal.

3	Math lab is understocked and not setup as per sop's of the Board. School should have a proper and well equipped math lab in compliance of rule 4.5 of the affiliation bye laws, 2018 and the Guidelines notified vide circular no 11/2022 and submit the compliance within 3 months on SARAS portal.
4	All Science labs i.e. Physics, Chemistry and Biology labs are understocked, without safety features and storage facilities. The school is required to upgrade the labs as per SOP's of the Board and submit the compliance through videography on SARAS portal within 3 months.
5	Less computers are seen in the Computer Lab, the school should procure more computers to maintain 1:18 computer to student's ratio or minimum 40 computers as per Circular no. 10 dated 24.03.2023 and submit the compliance through videography on SARAS portal within 03 months.
6	Boys urinals in general washroom are without partition as seen in the video, the school is required to build partition accordingly and submit the compliance within 3 months on SARAS portal.
7	The school is required to submit the bank statement for salary paid to teachers for last 6 months and teacher wise salary statement within 3 months on SARAS portal.
8	The school is directed to ensure that all essential valid documents are available under the head Mandatory Public Disclosure (as per annexure – IX) on school's website at all time and the link of certificates should be remain functional and submit an undertaking in this regard on its letter head duly signed by the principal and manager of the school in the compliance within 03 months.
9	As per the recommendation of NEP, the school shall ensure the participation of its students in the Structured Assessment for Analyzing Learning(SAFAL), an exam conducted by the Board every year. This exam, designed to assess and enhance students' learning, is a valuable initiative for their holistic development, as per the guidelines issued by the Board vide circular no: Acad-49/2024 dated 26 June 2024.
10	The school will ensure the Holistic Progress Card (HPC) is used for the foundational stage according to the guidelines issued by the Board via notification no. CBSE/Director (Acad.-Assessment)/2023 dated 27.12.2023.
11	The school shall conduct training of its teachers with CoE Bengaluru within 03 months and submit the compliance.
12	The school shall insure to conduct at least 50 hours of Continuous Professional Development (CPD) every year for all the teachers vide notification no. 16/2021 dated 24.09.2023 out of which 25 hours should be from COE Bengaluru.
13	The school shall submit an undertaking to upload all requisite information regarding students, teachers, and infrastructure details available in the school on the UDISE and OASIS Portals. The registration of the students in classes IX and XI shall be conditional on the school providing complete information on the UDISE and OASIS Portals.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye - Laws-2018.

2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted within the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
